2023 AGM of the Kensington Residents and Ratepayers Association (KRRA)**
Saturday 18 March 2023 from 9.30 for 10am-1pm at the Community Centre in Rhodes Park

Executive Committee Election Guidelines

In line with the prevailing Constitution of the KRRA (2017), the current Executive Committee of the KRRA will step down, and the members of the association must elect new office bearers and additional members.

Also in line with the Constitution, an eligible candidate must:

- Be a resident and/or a ratepayer in the area (proof may be required)
- Be a member of the KRRA in good standing, and duly nominated and seconded by members in good standing
- Be present at the meeting at which they are nominated and accept nomination or, if unable to be present at the meeting, they may submit their written proposal, secondment and acceptance by lodging these with the secretary prior to or at the commencement of the meeting.

Section 6.1 of the Constitution says that the management of the Association shall be vested in the Executive Committee which shall consist of a Chairperson, Deputy-Chairperson, Secretary and Treasurer, and a minimum of four and a maximum of nine other members. The Constitution also says that all Executive Members are elected at an AGM, although there are mechanisms for taking on additional members or replacing members between AGMs.

Therefore, for the 2023 AGM, the KRRA is inviting nominations for the four office-bearers and for at least four additional members and not more than nine additional members.

If one of the four office-bearer positions is uncontested, the one person nominated will be duly elected. If the position is contested, there will be an election and the nominee with the most votes will be duly elected.

If the meeting fails to nominate a minimum of four additional members, those nominated will be duly elected and it will be the responsibility of the Executive to ensure that any vacancies are filled not more than 45 days after the AGM.

All those nominated to be additional members, up to a total of nine, will be duly elected as additional members. In the event that more than nine nominations are made for additional members, there will be an election and the nine nominees with the highest number of votes will be duly elected to the Executive Committee. A run-off election can be held to finalise the list of nine if the outcome of the election does not produce a conclusive list of nine winners.

Nominations for additional members can be accompanied by a recommendation that the nominated member be responsible for a particular function. whether or not the AGM has agreed on specific portfolios additional to the four listed in Section 6.1 of the Constitution. The new Executive will be tasked with allocating responsibilities to the additional members, either to fill additional portfolios agreed on in the AGM or by creating new portfolios for them to fill. The Executive will be required to present the final configuration of portfolios for ratification to the first Members' Meeting to take place after the AGM.
